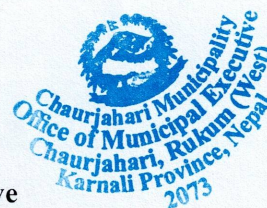

7. Bids shall be opened in presence of Bidders' representatives who choose to attend on 2079/09/21, 12:30 PM at the office of Chaurjahari Municipality. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of 1,07,500 which shall be valid for minimum 30 days beyond the bid validity period.
8. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
